

5. **Applicant must have a recommendation from her/his principal, counselor, or teacher.**
6. **Applicant must write an essay (150 – 500 words) on why his/her chosen field is important to the legal system and why he/she chose that particular field.**
7. **Applications must be postmarked by April 1, 2026.**
8. **Decision of the Selection Committee is final. No materials can be returned.**
